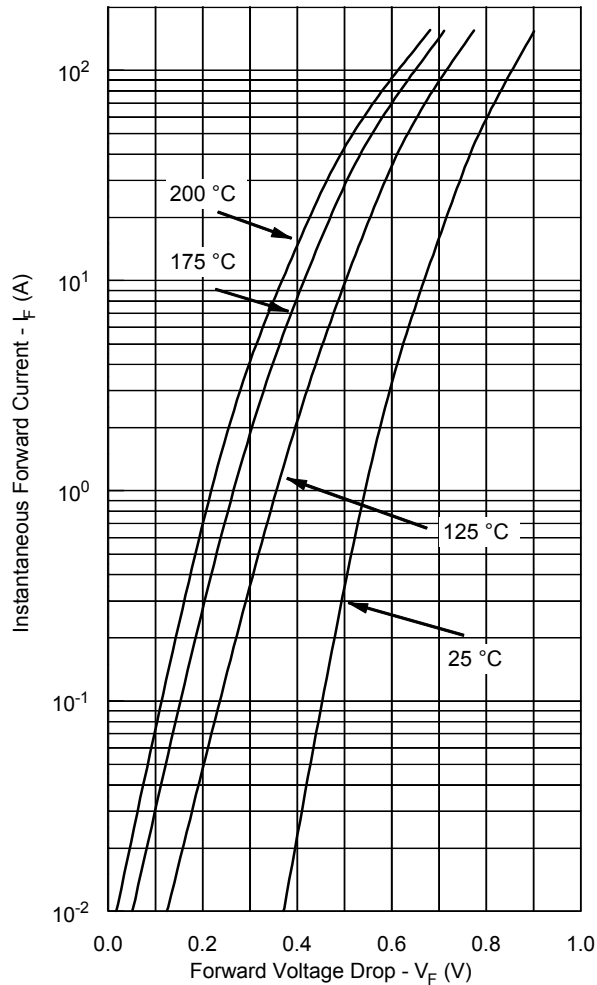

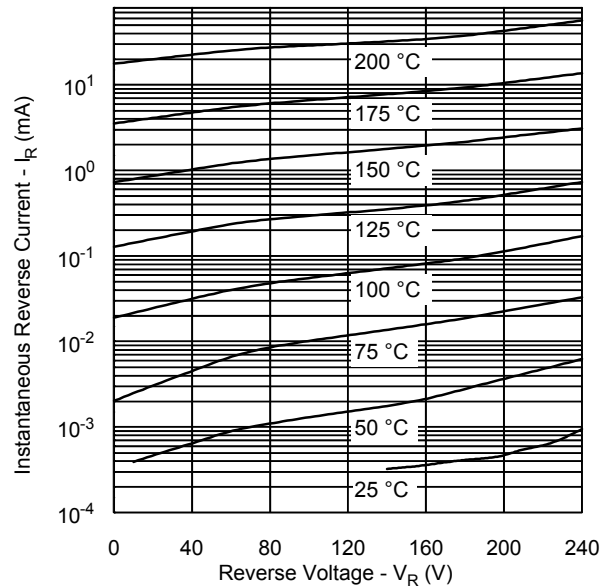

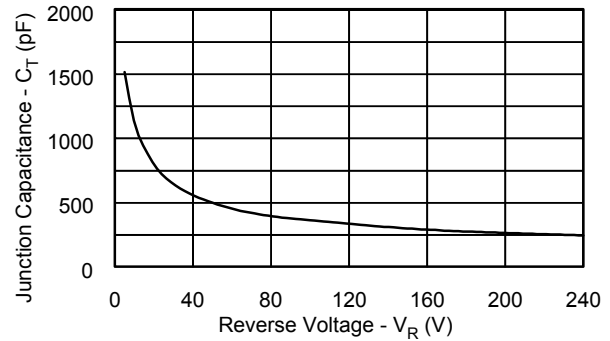
Typical Forward Characteristics

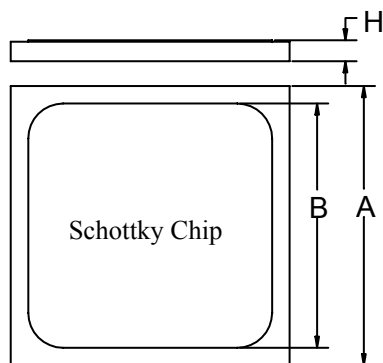

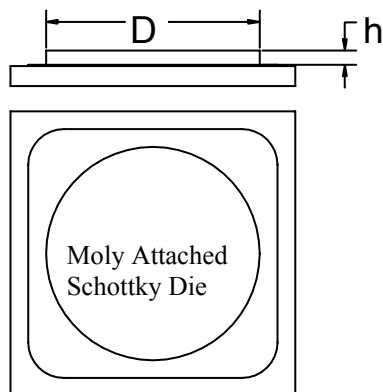
